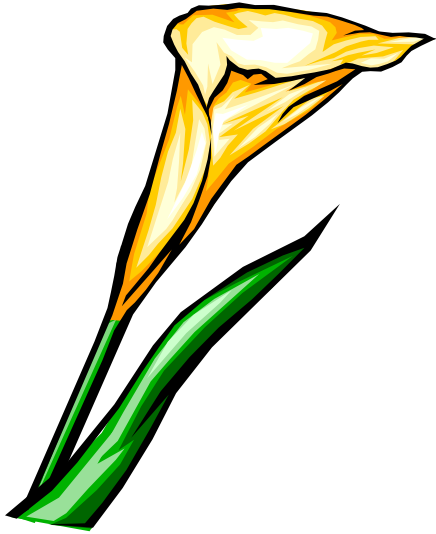
## Snapped a Great Kid Picture Lately?

Six new members have been added to the STARS Board of Review to fill vacant or expiring terms on the board.

In January the Board welcomed Susan Collamer, a home child care provider from Saratoga, and Jo Madsen, a center provider from Sheridan to the board. In March four additional new members were added. They are Jennifer Leonhardt, a home provider from Lovell, Laura Stadtfeld, a home provider from Casper, Marie Wilson, a center director from Rock Springs, and Jennifer Zook, a center director from Laramie.

The board will meet for a face-to-face retreat on Saturday, May 1, in Riverton to review the work of the past year and plan the work of the coming year. The board also said goodbye to longtime board member Joan Bangen who had faithfully served on the board since 2007.

In the past year the Board of Review has been involved in the revisions of the instructor and class approval forms for STARS. Created a pre-approved national conference list for STARS and streamlined conference evaluation form.

The Board also clarified how college credit is approved for STARS credit and why adult learning principals should be considering in training for care providers.

## STARS Clearinghouse reviewed

The STARS Clearinghouse is being reviewed. Outdated items are being removed and others are being moved to a new resource section. This section will still be available for loan but not generate training credit. New selections will be added.
